

### Steps for Becoming a Member

We place a two-week hold on all personal checks prior to activating a membership. To reduce delay, use a certified check, money order or credit card. Please call prior to bringing a payment in person.

Ask if you are on the NCCC list. If so, you may apply for credit union membership immediately without confirmation .

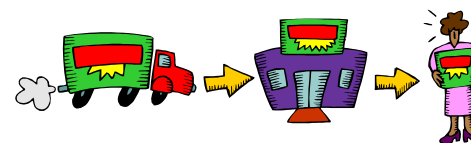

All NCCC members are eligible for **credit union membership** at Coastal Federal Credit Union ([www.Coastalfcu.org](http://www.Coastalfcu.org)) and Members Credit Union ([www.MemCU.com](http://www.MemCU.com)). Unlike traditional banks, credit unions are member-owned and usually charge substantially lower fees. Once you become a member of NCCC, the credit unions are automatically notified of your eligibility via our computer network.
