Scholarship applications for the 2010-11 academic year are now available on our website at www.memcu.com. Under the "Tools" tab on our homepage click on "Forms" then "Scholarship Application." You may also receive an application by calling 800-951-8000 ext. 134. The deadline for completed applications is February 12, 2010. Applicants must be a Members Credit Union member to be eligible for consideration for a scholarship.

In 2009 Members Credit Union awarded 23 deserving members aca-



demically and need based scholarships totaling \$22,000. These included the \$3,000 John R. Loftin Scholarship awarded to Megan Smith of Valdese, NC, and the \$2,000 Dan Elkins Scholarship given to Kaylie McCraw of Marion, NC.

Members Credit Union is proud to offer our members the opportunity to earn a scholarship to continue their education. Since the inception of our program in 1996, MCU has awarded 152 scholarships totaling \$118,000.
